NOTIFICATION.

S.O. 1131... Whereas by the notification of the Government of India in the Department of Mines and Fuel (Ministry of Steel, Mines and Fuel), S.O. No. 992 dated 30th April, 1959, under sub-section (1) of section 7 of the Coal Bearing Areas (Acquisition & Development) Act, 1957 (20 of 1957), the Central Government gave notice of its intention to acquire the lands in the locality specified in the schedule appended to that notification and reproduced in the Schedule to this notification.

And whereas by the notification of the Government of India in the Department of Mines and Fuel (Ministry of Steel, Mines and Fuel) No. S.O. 1069 dated the 8th May, 1959 under Section 9A of the said Act, the Central Govt: directed that the provisions of Section 8 of that Act shall not apply in respect of the said lands;

And whereas the Central Government after consulting the Government of Bihar, is satisfied that the lands measuring 45.30 acres described in Schedule appended hereto should be acquired;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 9 of the said Act, it is hereby declared that the lands measuring 45.30 acres described in the said schedule are hereby acquired.

The plans of the areas covered by this notification may be inspected in the office of the Deputy Commissioner, Hazaribagh or in the office of the Coal Controller, 1, Council House Street, Calcutta or in the Office of the National Coal Development Corporation (Private) Ltd. (Revenue Section), Darbhanga House, Ranchi.
