NOTIFICATION

S.O.3748 Whereas by the notification of the Government of India in the then Ministry of Steel, Mines and Coal (Department of Coal) No.S.O.2237 dated the 8th May, 1985, under sub-section(1) of Section 7 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957), published in the Gazette of India, part II-Section 3 sub-section (ii) dated the 25th May, 1985, the Central Government gave notice of its intention to acquire the lands measuring 270.00 acres (approximately) or 109.26 hectares (approximately) in the locality specified in the Schedule appended to that notification;

And whereas the competent authority, in pursuance of section 8 of the said Act, has made his report to the Central Government;

And whereas the Central Government, after considering the report aforesaid and after consulting the Government of Bihar is satisfied that the lands measuring 270.00 acres (approximately) or 109.26 hectares (approximately) described in the Schedule appended hereto;

should be acquired.

Now, therefore, in exercise of powers conferred by sub-section (1) of section 9 of the said Act, the Central Government hereby declares that the lands measuring 270.00 acres (approximately) or 109.26 hectares (approximately), described in the Schedule appended hereto ;

are hereby acquired.

The plans of the area covered by this notification may be inspected in the office of the Deputy Commissioner, Hazaribagh (Bihar) or in the office of the Coal Controller, 1, Council House Street, Calcutta-1 or in the office of the Central Coalfields Limited (Revenue Section), Darbhanga House, Ranchi (Bihar).
