NOTIFICATIONS

S.O. 51(E).-Whereas by the notification of the Government of India in the Ministry of Steel and Mines (Department of Mines) No. S.O. 3158-3159 dated the 19th August, 1971, under sub-section(I) of section 7 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957) published in the Gazette of India Extraordinary dated 24th August, 1971, Part II, section 3, sub-section (ii), the Central Government gave notice of its intention to acquire the lands described in the schedule appended to that notification;

AND WHEREAS the competent authority in pursuance of section 8 of the said Act has made his report to the Central Government;

AND WHEREAS the Central Government, after considering the report aforesaid, and after consulting the Government of Bihar, is satisfied that out of the lands described in the schedule to the said notification the lands measuring 2557.00 acres (approximately) or 1034.77 hectares (approximately) described in the schedule appended hereto should be acquired;

NOW THEREFORE, in exercise of the powers conferred by sub-section(i) of section 9 of the said Act, the Central Government hereby declares that the lands measuring 2557.00 acres (approximately) of 1034.77 hectares (approximately) described in the said schedule be acquired.

2. The plans of the area covered by this notification may be inspected in the office of the Deputy Commissioner, Hazaribagh (Bihar) or in the office of the Coal Controller, 1, Council House Street, Calcutta or in the office of the National Coal Development Corporation Limited (Revenue Section), Darbhanga House, Ranchi (Bihar).

BOUNDARY DESCRIPTION:
