- 1. This notice is in continuation of NIT No. CCL/GM(CMC)/A&C/GeM/2024/48, dated 05.12.2024 GeM ID GEM/2024/B/5666492 with the estimated Cost of Work including GST @ 18% amounting to Rs. 10206,53,80,901.80 and subsequent direction of Hon'ble Supreme Court {SLP (C) No.21278 of 2025} where Hon'ble Supreme Court directed to resume the proceeding from the stage of Financial bid. The direction of Hon'ble Supreme Court is as below:-
- (i) A Floor Price / Discovered Price / Base Price INR 8277,50,23,911.36 with GST shall be the benchmark.

- **3.** The Floor Price / Base price in view of Hon'ble SC direction for the present notice is Rs. 8277,50,23,911.36 with GST and the said floor / base price would also be treated as Reserve price for the calculation of APS (Additional Performance Security).
- **4.** All NIT terms and conditions of tender (vide GeM ID GEM/2024/B/5666492) including Guidelines on Debarment of Firms from Bidding will be applicable for this notice.
- **5.** In addition to the terms and conditions of GeM ID GEM/2024/B/5666492, Additional Performance Security (APS) will be applicable and will be calculated as the difference between New Quoted Price and the Reserve Price with other modalities as below:-

APS will be submitted as per relevant provisions of clause 4.6 of SLA, needs to be furnished within 21 days of issuance of LOA by the successful Bidder.
