

## Expression of Interest

EOI is invited from interested and reputed service providers to enter into a contract with CCL to set up and run CT scan facility at Gandhi Nagar Hospital, Ranchi of Central Coalfields Limited.


The major terms and conditions of the contract will be as follows –

1. The service provider will enter into a contract with CCL for 5 years to install and run a "16 slice or more" CT scan machine (hereinafter referred as Machine) and related facility at Gandhi Nagar Hospital, CCL, Ranchi. Based on the performance, the contract may be extended for further five years with mutual consent.
2. The period of 5 years will be deemed to be started from the date of the start of the machine at GNH. However, the successful bidder has to ensure the start of machine within two months of receiving work order from CCL.
3. Service provider will provide CT radiology services as advised to indoor / outdoor patients of GNH and other hospitals of CCL
4. The service will be provided at CGHS rates after producing the referral letters by the patients of CCL hospitals.
5. For non-CCL patients, the service provider will charge normal market rates.
6. CCL will give a guarantee of minimum monthly amount, calculated on the basis number of minimum required patients multiplied by rates (not higher than CGHS rate / rates), payable to service provider. For this, the service provider will submit a monthly bill of minimum guaranteed amount or actual amount, whichever is higher, supported with all necessary documents, to CMS (I/c), GNH which will be forwarded to finance department of HQ for payment to the service provider,
7. Service provider will install and run a new technological updated CT Scan machine of reputed brand at GNH with operators and technicians.
8. The maintenance of the machine and its smooth running will be ensured by the service provider
9. GNH, CCL will provide an AC room with adjoining waiting room with wash room, electricity and other basic amenities free of cost to run the machine by service provider smoothly and efficiently.
10. Interested service providers will submit following details with their bids -

- i. Name, address, experience, reputation, contact details etc of the bidder with supported documents,
  - ii. Make, brand and other related qualitative & quantitative parameters of the Machine,
  - iii. Guaranteed minimum amount required from CCL every month, as mentioned in point no 6 above,
  - iv. Certified details of their authorized person
  - v. Signed copy of this EOI as a proof of acceptance
  - vi. An undertaking from the bidder that "the bidder has not been debarred by the Central government / State Government or any entity controlled by it, from participation in tender in any manner in the last two years".
  - vii. Any other important documents which the bidder desires to be submitted.
11. Service provider should have minimum three years' experience of running CT machine in its campus or in any recognized hospital.
12. The bidder quoting minimum monthly guaranteed amount, required from CCL, will be selected for service, subject to fulfilment of all required technical and commercial specifications. However, CCL reserves the right to cancel all bids on the ground of financially unviability or any other reason.
13. Successful bidder will deposit an amount of Rs. 10,00,000.00 (Rs. Ten lakhs only) in the designated account of "Central Coalfields Limited" as security deposit within one month of issuance of work order.
14. Security deposit will be refunded to service provider without any interest after successful completion of the contract.
15. In case of the breach of any point of the contract or any loss to CCL, the amount of security deposit will be forfeited by CCL or part thereof, as the case may be.
16. If due to any reason the machine does not work in a particular day or a number of days, the minimum guarantee by CCL will be reduced proportionately in that particular month.
17. Service Provider will ensure sanitization of the machine after every CT scan of the patient.
18. The extension of contract can be done with the mutual consent of both the parties. Both the parties have a liberty to exit the contract after giving a notice of three months,
19. CCL will not be responsible for any illegal use of the machine by the service provider or for any loss to patient / premises due to CT scan.











20. All tax liabilities regarding installation and running of the machine will be borne by the service provider,
21. Service provider will ensure that related rules / laws of the CCL / state / country are being followed.
22. GNH, CCL reserve the rights to reject or accept the bids or cancel the tender without assigning the reasons thereof.
23. In case of any dispute, it will be settled amicably. However, if it could not be settled amicably then the same will be settled in accordance with the Arbitration and Conciliation Act'1996.
24. Arbitration process shall be held at Ranchi and the language of the Arbitration proceedings and that of all documents and communications between the parties shall be English.
